

## Decree no. 8704 dated 25/01/2018

Regulates [Law no. 18,669, dated December 22, 2015](#), that addresses the transportation of live animals of animal health interest with an added-trade value on highways and roads in the State of Paraná

The Governor of the State of Paraná, by virtue of the powers invested in him by Article 87, items V and VI of the State Constitution,

Considering the provisions of Article 4 of [Law no. 18,669, dated December 22, 2015](#), as well as the provisions in Protocol no. 14,969/DIRATDIRBENSPREV843-4,

Decrees that:

Article 1. The Animal and Plant Health Inspectors (FDA) of the Paraná Agency for Animal and Plant Health (ADAPAR), as part of their duties, shall inspect the Animal Movement Permit (GTA - Guia de Trânsito Animal) and the other obligations and guidelines to be complied with regarding the transportation of live animals of concern to animal health, with added commercial value, and intended for breeding, stocking, fattening, reproduction or slaughter, on the roads and highways in the state of Paraná.

Paragraph 1. In the event there are no ADAPAR Animal and Plant Health Inspectors (FDA), the following individuals are competent to check the compliance of the Animal Movement Permit (GTA):

I - ADAPAR Assistants for Animal and Plant Health Inspection - AFDA;

II - the Highway Military Police, the State Highway Police - PRE.

Paragraph 2. Failure to produce the Animal Movement Permit (GTA), or producing non-compliant GTAs, regarding the transported load, shall be notified as established by ADAPAR, and the vehicle shall be retained until an FDA provides a formal decision.

Article 2. The transportation of animals described in Article 1 of this Decree shall be considered violative when:

I - Not accompanied by the GTA;

II - performed without the additional mandatory health documents, or with changes, erasures or tampering;

III - The origin or destination of the entire consignment, or part of it, is a farm or establishment different other than what is stated on the GTA, without the appropriate and express authorization of ADAPAR.

IV - the transported truck load differs from the specifications on the GTA regarding species, gender, age bracket or number of animals.

Article 3. During inspections by ADAPAR at the State Highway Police Stations, or during inspections at the Agricultural Transportation Inspection Posts (PFTA), or in mobile inspections when a Highway Military Police Officer is present, this officer shall stop the vehicles to be inspected, and provide the necessary security for the effective inspection activity to be performed.

Article 4. ADAPAR shall provide the appropriate training to the FDA, AFDA and Highway Military Police Officers regarding compliance with the required documents and the measures to be put in place if a non-compliance is found regarding the transportation of animals referred to in this Decree.

Article 5. In the event this Decree not complied with, the provisions contained in Law no. 11,504, enacted August 6, 1996, shall be applied, as applicable, which addresses Animal Health in the State of Paraná, and its regulation approved by Decree no. 12,029 dated September 1, 2014.

Article 6. This Decree shall come into force as of the date of its publication.
