

LAW No. 17,025 - DECEMBER 19, 2011

AUTHORIZES THE EXECUTIVE BRANCH TO CONCEDE A SOCIAL GRANT TO THE PARANÁ AGRICULTURAL AND LIVESTOCK DEVELOPMENT FUND (FUNDO DE DESENVOLVIMENTO DA AGROPECUÁRIA) - FUNDEPEC/PR, AS SPECIFIED.

Published in the Official Gazette no. 8612 dated December 19, 2011

The Legislative Assembly of the State of Paraná decrees, and I ratify the following Law:

Art. 1 The Executive Branch is authorized to concede a social grant to the Paraná Agricultural and Livestock Development Fund - FUNDEPEC/PR, a not-for-profit civil society entity, by transferring resources collected by the fees as laid down by Law no. 11,504, enacted August 6, 1996, for the sole purpose of compensation for the owner of animals killed as a result of animal health actions in the state of Paraná.

Paragraph 1. Conceding a social grant is based on the agreement signed between FUNDEPEC and the State of Paraná, where the obligations and other relevant conditions are set forth.

Paragraph 2. The Executive Branch will transfer to FUNDEPEC/PR the amount collected in previous years coming from the collection of fees about animal health, and, quarterly, the collected amount is deposited in the Agricultural Equipment Fund (FEAP - Fundo de Equipamento Agropecuário).

Paragraph 3. Financial transfers that occurred in the period from 09/10/1999 to 01/12/2005 are ratified, which are made by means of specific agreements with the Executive Branch and FUNDEPEC-PR.

Art. 2 In sanitary emergency situations, when requested by the Secretary of State for Agriculture and Food Supply, FUNDEPEC/PR may take on the cost expenses up to the limit of 10% of the amount corresponding to the stamping out.

Art. 3 The transferred resources set forth in this Law shall be kept deposited in an official financial institution, in a single and special account, and the result of the financial applications shall be fully used for the purposes of the mentioned transfers.

Sole Paragraph. The expenses arising from the application of the resources set forth in this Law shall be performed by issuing nominal checks to the beneficiaries.

Art. 4 Expenses resulting from investments made when using the resources referred to in Article 1 hereof are prohibited.

Art. 5 The State Budget Law shall lay down the conditions for the application of this Law.

Art. 6 FUNDEPEC/PR shall render account regarding the use of the resources, every year, to the State Council on Animal and Plant Health (CONESA - Conselho Estadual de Sanidade Agropecuária) and to the Public Finance Court of the State, within legal form and deadlines.

Art. 7 This Law shall come into force on its publication date.
