



ORDINANCE (PORTARIA) No. 332, DATED OCTOBER 24, 2019.

Lays down measures and procedures for bringing the registry of livestock farms in the State of Paraná up to date.

THE DIRECTOR-PRESIDENT OF THE ANIMAL AND PLANT HEALTH AGENCY OF THE STATE OF PARANÁ - ADAPAR, by virtue of the powers conferred upon him by Article 18, item VIII, of the Appendix referred to by State Decree no. 4,377, dated April 24, 2012, and in conformity with State Law no. 17,026, dated December 20, 2011, with State Law no. 11,504, dated August 6, 1996, with State Decree no. 12,029, dated September 1, 2014, and

Whereas there is a need and an obligation to maintain the registry of livestock farms up to date in ADAPAR, for the purposes of animal health control,

RESOLVES:

CHAPTER I

REGARDING THE CAMPAIGN FOR THE UPDATING OF HERD STOCKS

Article 1. To establish measures and procedures for bringing the registry of livestock farms up to date in compliance with State Decree no. 12,029, dated September 1, 2014.

Article 2. The updating of the registry consists of a registration operation intended to keep up to date all the data of the rural establishment and of the owner, which are essential for the official animal health service, and which include (among other items):

- a) the identification, address, and contact of the farm owner;
- b) the identification, address, and contact of the farmer;
- c) the identification, address, geo-referenced location, contact, and data on the access to the farm;
- d) the number of animals, per species, sex, and age bracket.

Article 3. Every livestock farmer in the state of Paraná is hereby obliged to update the data in the Registry.

- Article 4. The updating of the registry will be performed periodically by means of a Campaign for the Updating of Herd Stocks, to be carried out in two stages:
 - a) first step: May 1-31;
 - b) second step: November 1-30.

Sole paragraph. ADAPAR may exceptionally, and in order to meet the interests of animal health, in the case of species which it deems relevant, put back, or bring forward, or dispense with, the Campaign for the Updating of Herd Stocks, or even carry out additional campaigns either in the State or in a given region of the same.

- Article 5. During the steps of the Campaign for the Updating of Herd Stocks, it is mandatory to bring the registry up to date, and it is for the owner of the animals, or his/her legal representative, to do this.
- Article 6. The livestock farm must update its registry information on-line, using computerized Internet access at the ADAPAR worldwide web page at www.adapar.pr.gov.br.
- Paragraph 1. A login and password that are unique to the farmer or his/her legal representative are required for on-line confirmation;
- Paragraph 2. The password is personal and non-transferrable, and the farmer or his/her legal representative shall be held liable for any use by another user.
- Article 7. If it is impossible to access the Internet, the farm's registry may be updated by filling out and presenting the form entitled "Campaign for the Updating of Herd Stocks", in accordance with the Appendix to this Ordinance.
- Paragraph 1. ADAPAR may amend the form in the Appendix to this Ordinance in order to obtain information of interest to animal health.
- Paragraph 2. The documentary proof demanded during stages of the Campaign for the Updating of Herd Stocks as laid down in this Ordinance, shall be used in order to feed the ADAPAR database.
- Paragraph 3. In order to prove that the farm's registry has been updated by using the printed form, the farmer should:
- a) obtain the form entitled "Campaign for the Updating of Herd Stocks" (attached hereto), in two copies, from the Local Livestock Health Unit (*Unidade Local de Sanidade Agropecuária* ULSA) of ADAPAR, in the Municipal Service Office (*Escritório de Atendimento do Município* EAM), or from authorized rural unions, or from the ADAPAR Internet page at *www.adapar.pr.gov.br*, or yet from some other location made available by ADAPAR.
- b) present both copies of the "Campaign for the Updating of Herd Stocks" to the ADAPAR ULSA, or to the EAM, having duly completed and signed them.
- c) The top copy of the Campaign for the Updating of Herd Stocks will be kept on file at the ULSA (ADAPAR) and the farmer shall keep the second copy, after it has been stamped and initialed.
- I. During the official period laid down in Article 4, the Updating of Herds may be proven in any of the ADAPAR ULSAs.

- II. Upon completion of the official term for each campaign provided for in Article 4, proof of updating the herd may only be accomplished at the ULSA within the jurisdiction of which the livestock farm is located.
- III. Municipal Service Offices and authorized unions may only receive the Campaign for the Updating of Herd Stocks from livestock farms within their own area of jurisdiction.
- Article 8. ADAPAR may, at any moment, order the updating of the registry of any livestock farm, regardless of any Campaign for the Updating of Herd Stocks.
- Paragraph 1. The farmer, or the legal representative of the livestock farm, must be notified by ADAPAR if the updating activity referred to in the head provision is to be carried out.
- Paragraph 2. The farmer or his/her legal representative, having been notified, must on the date and at the time scheduled by the ADAPAR Local Livestock Health Unit make available the infrastructure and any other resources needed for updating the registry, which may include checking and counting the herd.
- Paragraph 3. If a farmer fails to comply with the notification provided for in this article, the registry of their livestock farm will be deemed not to have been updated.
- Article 9. Failure to update the registry in the terms laid down in this Ordinance will result in compulsory updating, without prejudice to administrative accountability actions.

CHAPTER III

ANIMAL MOVEMENTS

Article 10. After the stages provided for in Article 4 of this Ordinance, the issuance of an Animal Movement Permit (GTA - *Guia de Trânsito Animal*) is dependent upon proof of the updating of the herd of all the animal species on the livestock farm.

Sole paragraph. During the stages provided for in Article 4 of this Ordinance, the issuance of an Animal Movement Permit (GTA - *Guia de Trânsito Animal*) for any animal gathering (shows, fairs, auctions, sporting event or others) will be conditional upon the updating of the herd for the species to be transported.

CHAPTER IV

GENERAL PROVISIONS

Article 12. All livestock farms must either possess or have access to a minimum handling structure that is capable of bringing together and restraining the animals for checking and counting to update the registry, as well as all other sanitary handling and animal health protection activities.

Paragraph 1. Those animals kept in places lacking the minimum structure capable of ensuring what is laid down in the head provision to this article will be subject to elimination, removal to another establishment, or sale to slaughterhouses, at the discretion of ADAPAR.

Paragraph 2. The farmer will be liable for the expenses arising from the application of Paragraph 1 of this Article.

Article 13. Failure to comply with the provisions of the present Ordinance will render the offender liable to the enforcement sanctions provided for in State Law no. 12,029/2014, without prejudice to civil and penal liability.

Article 14. This Ordinance shall come into force on its publication date.
